

K-5 Comer Common to Sections 11, 12, 13, & 14, T45N, R10W

1849 - Original corner established by William Ives.

Witnesses: Sugar 7, N51°W 27 links - Sugar 12, S72°E 37 links.

1966 - Highway M-123 plans show corner at intersection of Highways M-123 and M-28.

1990 - Neil E. Hill, P.S. 27447, LCRC recorded in File 435, Luce County Corner Records. Found axle shaft in monument box. Witnesses: PK Nail in Corner of Bituminous Parking, S55°W 180.56' - West Bolt of Light Pole, N40°E 210.14' - North Bolt of (2) West Bolts for Sign, N10°E 267.60' - Power Pole, N25°W 107.68'.

1993 – Dennis R. Destrampe, P.S. 18983, LCRC recorded in Liber 2, page 468, Luce County Corner Records Found axle shaft in monument box, reset a 5/8" pin in a monument box after road construction. Witnesses: CO Chiseled "x" on West Bolt of Light Pole, N40°E 210.14'

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being perpetuated as part of the Luce County Remonumentation Program.

Found a 5/8" iron pin in a monument box and three of the record witnesses as shown above. Accepted corner as found and established two additional witness objects.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Found a 5/8" iron pin in a monument box at the corner location, at the intersection of Highways M-123 & M-28. Witnesses:
