I, William L. Karr, in a field survey on December 19, 1997, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and for that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

Could find no subsequent survey history on this corner in available public records.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(F-3) 1/4 Corner Common to Sections 4 and 9, T. 45 N., R. 11 W.

This corner is being perpetuated as part of the Luce County Remonumentation Program.

Found no evidence of the original corner.

Old M-28 used to go North-South through sections 4 and 9 and crossed the section line West of the 1/4 corner. Could find no plans for the old road in either the MDOT office in Newberry or the Luce County Road Commission office. Found a 2 page sketch for a description for a borrow pit on the East side of M-28 and on the South side of section 4 in the Road Commission Office. The notes and the description for the parcel do not mention the 1/4 Corner. Found a pipe on an East - West fence line at the East ROW of the North - South (now) county road; the Southwest corner of the borrow pit parcel. The fence runs parallel to a line between the section corners to the East and West and 22' North of that line.

Reestablished the 1/4 corner on line by proportionate measurement between the section corners East and West.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner.

(F-3) 1/4 Corner Common to Sections 4 and 9, T. 45 N., R. 11 W.

Corner is a 1/2" x 48" re-bar with a stamped aluminum Luce County Remonumentation cap. The corner falls on the Southerly slope of a large hill, 22' South of a row of fence posts and 230' East of the centerline of a county road.
