

(H-13) 1/4 Corner Common to Section 34, T. 45 N., R. 11 W. and Section 3, T. 44 N., R. 11 W. This corner is being perpetuated as part of the Luce County Remonumentation Program.

A careful search of the area could recover no evidence of the original corner or of subsequent restoration. Re-established the corner by single proportionate measurement on the township line between the section corners 1/2 mile East and 1/2 mile West.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
