

5. Private Claims

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(I-2) 1/4 Corner Common to Sections 2 and 3, T. 45 N., R. 11 W. This corner is being perpetuated as part of the Luce County Remonumentation Program.

Found no evidence of the original corner or of subsequent restoration.

Reestablished the 1/4 corner on line and by single proportionate measurement between the section corners to the North and South. Distance North is 2544.96' (GLO), 2538.66' (meas) and South is 2640' (GLO), 2633.46' (meas).

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(I-2) 1/4 Corner Common to Sections 2 and 3, T. 45 N., R. 11 W.

Corner is a 1/2" x 48" re-bar with a stamped aluminum Luce County Remonumentation cap. The corner falls in a wooded area approximately 440' North of an old RR grade.
