B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Corner reestablished as part of the Luce County Remonumentation Found Witness Corner pipes in the Northeast and Southwest quads, believed to be set by County Surveyor J. Kinsey. 1 1/4" O.D. pipe, 12" B.G. in Northeast quad. Remains of 2" O.D. pipe in Southwest quad (Pipe hit in ditch work). Reset 2" pipe in approximate location and set a 1/2" x 48" iron in each pipe. Distance between pipes is 89.90'. Reestablished corner position midway and on line between found witness corner pipes. Corner position 0.32' from a prorated position. Found a cut-off 12" Cedar in Northeast quad with scribed blaze that faces corner (Cut-off 36" A.G.) that bears N60°E - 80.1' from corner position. Found a single strand of barb wire running to East. Corner falls 8' North of extension of said wire. Distance North to the Northeast corner of Section 27 is 2659.40'. Distance South to the Southeast corner of Section 27 is 2659.15'. Corner is 0.29' West of a straight line between said Section corners.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner is a 1/2" x 24" iron with a 3 1/4" diameter stamped aluminum cap, 1" below paved road surface. Falls 1' West of centerline of County Road 459 (North-South, paved).
