B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(L13) The original post and accessories were not recovered. Found no evidence of the position of the original corner on the ground. Reestablished the corner midway and on the curved Township line between Section corners of record 2630.31' east and west. The true bearing of the Township line was observed to be within 30 arc seconds of cardinal.
