Iron pipe in road set by County Surveyor Kinsey. Witness pipes have been removed by construction. Witnesses: Power Pole, N59°E 34.4' Power Pole, S35°E 45.4' Power Pole, S29°W 44.5' Corner is shown on several surveys by Eino Sainio.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

M-10 (T46N, R10W)

This corner is being perpetuated as part of the Luce County Remonumentation Program. 1" iron pipe and all witnesses as called for in 1980 records have been removed by road construction. Re-established corner from survey information obtained from Eino Sainio. Corner is 2634.50 feet from section corner to the north, 2635.88 feet from section corner to the south, and is 11.32 feet east of a straight line between said section corners.

Description of monument for corner and accessories established to perpetuate locating the position of the corner:

The Robert Book States

M-10 (T46N, R10W)

Corner is a 1" iron with plastic cap #33142 at the approximate centerline intersection of County Roads 461 north-south and 430 east-west. Witnesses:

Power Pole, N85°E 172.43' Power Pole, N63°E 35.43'

Power Pole (118-22), N73°W 116.24'

Power Pole (ML1-37), S36°W 76.06'

Note: Distances are to a nail and tag in the side of the pole. Bearings are compass bearings corrected for declination.
