A. Description of original monument and accessories and/or subsequent restoration:

A-1 Township Corner Common to T45N, R9W & T45N, 10W & T46N, R9W & T46N, R10W

Original ties to post: Beech 17, N31°W 27 links Beech 7, N56°E 25 links, 1973 - As recorded on page 132, Luce County Corner records, by Peter Chenard, P.S. 14200. Found 3/4" bar in centerline of road intersection.

1984 - Corner is shown on a site plan drawing for the Luce County Dry Kiln and Industrial Park, by Chippewa Architects and Engineers, Inc.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

A-1 (T45N, R9W)

This corner is being perpetuated as part of the Luce County Remonumentation Program. Found a railroad spike in the intersection of County Road 403 to the south and west, County Road 461 to the north, and County Road 440 to the east. Found one remaining witness as shown in LCRC, page 132, which checks well. Distances to 1/4 corners south and west check well with those as shown on above mentioned site plan drawing. Position appears to be a perpetuation corner location after road construction. Accepted corner as found.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner

A-1 (T45N, R9W)
Corner is a railroad spike approximately 1 foot south and 1 foot east of centerline intersection of County Roads. Witnesses:

14" Scotch Pine, S43°E 60.67' 6" Scotch Pine, S53°W 93.58' 12" Elm, N30°W 101.43' Light Pole, N52°E 44.91' Note: Distances are to a double headed spike in the side of the witness object. Trees are blazed and painted. Bearings are compass bearings corrected for declination.
