- A. Description of original monument and accessories and/or subsequent restoration:
- (C5) Corner common to Sections 7-8-17-18. 1851 Established by Francis Coleman Deputy Surveyor. Set post. Spruce 6" N43W 22 links, Spruce 8" S50E 24 links. 1974 - Reestablished by Billy D. Buckler RLS "by extending line thru two original Cedar Line Trees, 805.2' and 2059.2' West of corner. Found a Tamarack stump blazed, N70E, 17.0' from corner". Set 1"ID I.pipe with 4" aluminum cap. 14" Cedar N46W 38.7', and scribed 4" Balsam at corner.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (C5) The original post and accessories were not recovered. Found the 1974 monument in good condition and at record bearing and distance from the Cedar NBT NW, in good condition, and the Tamarack stump, no marks visible. The 4" Balsam "at corner" is now a stump. Accepted the monument as a careful and faithful reestablishment of the position of the original corner.
