(10-Sec. 34) South 1/16 corner between Sections 33 and 34. Not established in the original survey.

(I13) Corner common to Sections 34-35 T47N-R09W and Sections 2-3 T46N-R09W. 1961 - Remonumented by Billy D. Buckler RLS "from old wood post and old wood point which are in proper position from chopped out cedar to SE and badly decayed tamarack stumps to NW, NE & SW which may have been BTs". Set 1 iron pipe with 4" brass cap. 9" Cedar N54W 28 links, 8" Cedar N49E 25 links.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(10-Sec. 34) Established the corner midway and on the Section line between Section corner 1318.43' south and Quarter corner 1318.43' north.
