A. Description of original monument and accessories and/or subsequent restoration:

(12-Sec. 34) South 1/16 corner, Section 34. Not established in the original survey. 1965 -T.J.McLaren set post and iron for Cleveland-Cliffs Iron Company "at intersection of corrected N & S 1/4 line and corrected S 1/16 lines". Tam 12 N12W 7.4', Tam 10 N80E 12'.

(16-Sec. 34) East 1/16 corner between Section 34 T47N-R09W and Section 3 T46N-R09W. Not established in the original survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(12-Sec. 34) Recovered a 1" square iron rod, presumably the 1965 monument. I did not accept it as marking the position for the corner. The monument is not located at the record position, and the 1965 method used to determine the corner position is not proper. The monument does not appear to have been relied upon as the corner by local land owners. There is no evidence of improvements in the are and the 1965 position was not marked by any accessories indicating its acceptance as a title corner by any party. I established the corner midway and on a straight line between Center of Section 1318.38' north and Quarter corner 1318.38' south. The 1965 monument was found 4.4' south and 28.2' west of the position thus established.

(16-Sec. 34) Established the corner midway and on the Township line between Section corner 1321.79' east and Quarter corner 1321.79' west.
