Found W.Pine stump bottom bearing N57E 36 links. Corner lies in intersection of north and west fire lane". Set 1" pipe with 4" brass cap. 12" W.Pine N27W 64.5 links, 10" W.Pine S40E 68 links, 11" W.Pine N55E 96 links. 1980 - Remonumented by Billy D. Buckler RLS: "Replaced corner which was removed by logging traffic. Found remains of a concrete block 2' deep in soil" [this would be conc. base of Schaaf monument - sjs]. Set 1" pipe with 4" alum. cap. 1957 bearing trees were found in good condition in 1980, and at record bearing and distance. Found no other record of the Schaaf survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
