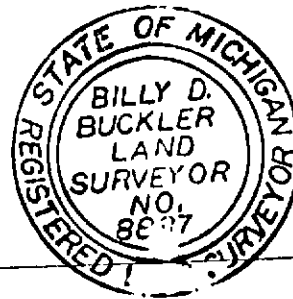
A. Description of original monument and accessories and/or subsequent restoration:
15-A, Sec. 15 Meander Corner bet. Sec's. 15-22, on Westside of Pike Lake.

B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
15-A, Sec. 15 Replaced corner from two original bearing trees. Cedar is a stub, standing, face plain, the tamarack is laying in water.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
15-A, Sec. 15 Placed 1" pipe with 4" aluminium cap at corner.
 New Bearings: 13" Cedar, N55°W, 17.7' and 11" Cedar, S72°W, 19.6'
 Corner monument set in the water, 6' from shore.
