- 1-Sec.7 Established corner by single prop. distance bet. sec. cor. to West and $\frac{1}{4}$ cor. East. Found paint line North - South at corner.
- 8-Sec.7 Established corner by a mean proportion between the West $\frac{1}{2}$ mile on Northside of Section 7 and the West $\frac{1}{2}$ mile on South side of Section.

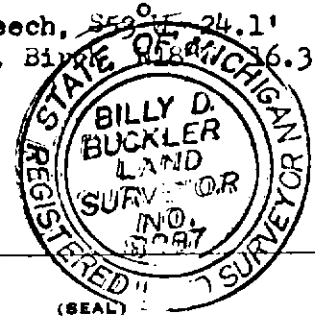
