- A. Description of original monument and accessories and/or subsequent restoration:
- (I9) Corner common to Sections 22-23-26-27. 1851 Established by Francis Colman, Deputy Surveyor. Set post. Maple 7" N2OW 15 links, Sugar 8" S40E 65 links. Marcus Schaaf RLS remonumented the corner with a 2" ID Iron Pipe, date unknown. No direct record of the Schaaf survey was found. 1959 Billy D. Buckler RLS recovered the 2" pipe set by Mr. Schaaf at record bearing and distance from the original BT Maple NW (fd. N36W 15 links) and replaced it with a 1"ID I.pipe with 4" brass cap. Corner lies at the intersection of firelines S. and E. NBTs 18" W.Pine S30W 61 links, 10" S.Maple N46E 55 links, 9" S.Maple S42E 37 links.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (I9) Recovered the 1959 monument in good condition and at record bearing and distance from the three 1959 NBTs, all in good condition with overgrown blazes. The original BT Maple NW is in place, now 24" DBH, still green, and checks with the 1959 record. Accepted the monument as a careful and faithful perpetuation of the position of the original corner.
- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(I9) Fd. 1"ID I.pipe with 4" brass MI Dept. of Conservation cap. Set measuring nail with MDNR tag in the side of: 24" Maple N37W 11.6' mrkd "S22" 1851 BT 15" Maple N53E 36.0' "S23" 1959 NBT
