- (K11) Section corner common to 25-26-35-36. 1952 Remonumented by Dean C. DeLaMater RLS in the original position as determined from one original B.T., still in place, in poor condition. Set 1" pipe with 4" brass cap. 20" W.Pine S70W 58 links, 10" J.Pine N53E 21 links.
- (3-Sec. 25) North 1/16 corner between Sections 25 and 26. 1964 Established by F.J.Bray RLS midway and on line between Section corner to north and 1/4 corner to south. Set 1" I.pipe with 4" alum. cap. 5" R.Pine S89E 45 links, 12" J.Pine West 06 links.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (K11) Found the 1952 monument in good condition and at record bearing and distance from the 1952 witnesses. The W.Pine SW (this tree is actually a Red Pine) is in good condition with overgrown blazes. The J.Pine NE is a stump. Accepted the monument as a careful and faithful perpetuation of the position of the original corner. The original BT noted in the 1952 record was not recovered.
- (3-Sec. 25) The 1964 monument was not recovered. Remonumented the corner in the 1964 position, in the hole apparently left after the monument's extraction by persons unknown, which hole was found at record bearing and distance from the BT Red Pine SE, found in good condition. The J. Pine BT, West, was not recovered.
