SUMMARY M-4

East 1/4 Corner, Section 12, Green Oak Township, Livingston County, Michigan.

Alex Holmes set post in a wet place in 1816 (See G.L.O. Notes).

1889 county surveyor field notes log stake, large stone, crockery & brick were set by I.T. before Grant Dunning in 1920.

In June of 1955, Omar E. McNutt survey records jog of 248.6 feet between A-3 and M-3, but does not record distance to or jog at A-4 and M-4.

On July 7, 1964, Wynn Wakenhut P.S. #8897 set 3/4" rod at East 1/4 Corner on fence line extended from the West. He also set 5/8" iron 11.79 feet S 67°51'45" W from found railroad spike in centerline of Silver Lake Road.

In 1969, Washtenaw Engineering found iron pipes at the East 1/4 Corner of Section 12, Green Oak Township, and West 1/4 Corner of Section 7, Lyon Township. The township jog measured 223.44 feet G.L.O. Notes record 239.58 feet.

1972 survey by Tredinnick shows the two jog irons set by Wakenhut in the Centerline of Silver Lake Road, however he did not show or use the M-4 as set by Wakenhut.

1988 plat by Ash uses the point set by Wakenhut, and the distanace to M-3 measures the same as Wakenhut also.

In 1997, Boss Engineering found Square Boat Spike 0.4 tenths below gravel surface (Dixboro Road). This point is the same as used by Wakenhut, Washtenaw, Munzel and Ash based on exiting witnesses and the distances to the North (M-3, and the iron in Silver Lake Road,) and distances to the the South (M-5, and A-5)

WITNESSES:

Act 74 by Munzel in 1978 is same point as used by all previos surveys based on witnesses.
