Found 1 1/2" inch axle shaft at surface of ground. Open field to the East and remnants of a fence found North, South & West. Measured to Witnesses found. Found 3 of 4 Munsell & Garlock Witnesses page 9 and they checked. Found 3 of 4 Russell Cole Witnesses page 10, they checked.

Witnesses Boss Engineering Survey page 16 and Witnesses Act 74 Boss Engineering page 17 are to 1/2" inch pipe assumed to be 26.86 North of 1/4 Corner. Found 5 of 7 Jekabson Act 74 Witnesses page 18 and they checked.

Note tie to Iron Pipe North of 1/4 Corner. Found 3 of 4 David Adams Witnesses page 19, they checked. Found 3 of 4 Munzel Engineering Witnesses page 21, they checked. Found 3 of 4 Boss Engineering Witnesses pages 25, 26, 27, 34 and they checked.

Found 3 of 4 Tri-County Witnesses page 31, they checked. Distance from the East 1/4 Corner of Section 23 to the East 1/8 line of said Section is 1293' feet ± Munsell & Garlock, David Adams & Tri-County Surveys this Dossier.

1299' feet ± Boss Engineering & Munzel Engineering Surveys. and 1296' feet ± Russell Cole Survey.

Distance from the East 1/4 Corner of Section 23 to the Northeast Corner of said Section is 2655' feet ± Boss Engineering and Warner & Warner Surveys. 2672' feet ± Grant Dunning and Russell Cole Surveys this Dossier. Many over hanging branches will make this Corner difficult for G.P.S..

Conclusion: Discrepency of Distances West may mean different locations at center of Section 23. All nine Surveyors Witnesses, except one Act 74 call for 1 1/2" inch axle or bar. We recommend this 1 1/2" inch axle as the East 1/4 Corner of Section 23.
