

K-04 T3N - R5E: West 1/4 Corner, Section 12, Oceola Township

We found a 1/2" iron off the SE side of the intersection of Green Road to the north and Dunn Road to the west on the northerly edge of a swamp. The corner falls on line with the westerly edge of gravel of Green Road extended south and 2 feet north of the north edge of gravel of Dunn Road extended easterly. There is a fairly recent (last 15 years) fenceline running easterly beginning 33.00 feet south of the section corner, and a fenceline to the south from this same point of beginning. The corner was originally recorded as being set by Sibley in 1823 for the GLO. The iron that currently marks this corner was recorded as being set by Oscar Boss in 1972 at a fence intersection, but no evidence of the remains of an intersection could be found. Current measure matches well with Grant Ward (1983), Boss (1972) and Hughes (1992). Witnesses checked with Boss, Ward and Hughes as well as with witnesses of unknown origin (see page 10). The Bullock distance to the south is within 2.5 feet of current, and the Bullock distance to the north differs with current measure by 20 feet. A sweep of the area near this location did not reveal any other corner markers. This corner is open and usable for GPS. I recommend accepting K-04, the West 1/4 Corner of Section 12, Oceola at the location as is presently monumented.
