

## L-13 - SOUTH 1/4 CORNER SECTION 36, T3N, R6E, OCEOLA TOWNSHIP

## SUMMARY:

There are two 1/2" irons which have been used over the last 15 years or so to mark the location of the South 1/4 Corner. They lie 5.06 feet apart and directly north and south of one another. The northerly iron measures 33.0 feet south of an iron at the corner of a cyclone fence, but approximately 5 feet north of the centerline of Golf Club Road.

The first recorded (and dated) use of either of these irons we could find was on a 1971 survey by David Finney (2), although it would appear that an undated survey by Pike Engineering (1) may predate the Finney work. The survey by Pike shows the South 1/4 Corner to be at the halfway point on the line between the SE and SW Corners of Section 36, with no deflection shown at the South 1/4 Corner. The survey by Finney shows the same distance to the SE Corner as Pike, as well as a found iron 990 feet north of the South 1/4 Corner which correlates with the NW corner of the Pike parcel. There is an iron set by Gary Boss in 1992 which falls very near the 1/2 distance point, 1.47 feet north of the straight line location from the SE to the SW Corners.

In 12 different surveys by Boss Engineering, the North 1/4 Corner of Section 1 Genoa has been used to control the direction of the South line of Section 36, with a jog then shown to continue easterly to the South 1/4 Corner on some surveys, and some of the surveys only showing the line extended to the North 1/4 Corner.

Beginning in 1977, Boss shows a found South 1/4 Corner that is 5.06 feet South of a "calculated" location. It would appear that this "calculated" location was arrived at by computation from found irons lying northerly of the South 1/4 Corner (3). I could find no evidence to indicate who set this southerly iron, but Boss field notes (4) call for a 1/2" iron with beatup cap. This point falls within 0.1 feet of an extension of line from the Southwest Corner of Section 36 through the North 1/4 Corner of Section 1, Genoa Township. The southerly iron fits road centerline well.

In 1992 Gary Boss set a South 1/4 Corner at the "calculated" location and witnesses a found iron 5.06 feet South.

There is a relatively new cyclone fence running north from the 2 irons at this location.

It appears that the northerly location predates the southerly, and would appear to have been set by an acgeptable method, therefor and would appear to have been set by an acceptable method, therefore I recommend using the northerly iron as set and witnessed by Boss.
