J-13, T3N, R6E: SOUTH 1/4 CORNER, SECTION 35, HARTLAND TOWNSHIP

The South 1/4 Corner of Section 35 was never placed by the GLO. The notes call for entering a "vary bad swamp" at 45 chains, but I believe that the correct distance was 25 chains from looking at the aerial photo and the fact that no post was set at the 40 chain mark (this has also been substantiated by "GLO" notes as transcribed and kept by C. Garlock). The North 1/4 Corner of Section 2, Brighton Township is a pipe set in the water. This pipe, as well as fenceline to the south is shown in the survey of the GM proving grounds from 1954 as the North 1/4 Corner of Section 2, Brighton. There is no northerly occupation in this area or for 1000 feet or more to the north due to swamp, but there is occupation to the south on the south side of Commerce Road. Boss Engineering has used the North 1/4 Corner of Section 2, Brighton as the South 1/4 Corner of Section 35, Hartland, although the Center as shown on the same survey is not on the North-South 1/4 line, and would much more closely agree with using the midpoint of the South line of Section 35. The North 1/4 Corner of Section 2, Brighton falls 1.1 feet south of the straight line between the SW and SE Corners of Section 35. There is old east-west fence 300 feet or so to the east which is approximately on the section line, but is shown to vary on the GM proving grounds survey. A sweep of the area found no additional irons. I recommend setting J-13, the South 1/4 Corner of Section 35, at the midpoint on the South line of Section 35, Hartland.
