



This section corner was first set by Deputy Surveyor Sylvester Sibley in late February. 1825. County Surveyors records dating to 1895 provide a witness for this point but the corner material was not identified.

In the modern era, Charles E. Garlock identifies this corner as a railroad spike in the fall of 1971 and records the same on LSC 90. Of the three witnesses recorded on that document, two can still be identified in the field. Later that year, in December Oscar Boss notes the same material marking the corner; however, his survey, CLS 367, provides three different witnesses. All three of these witnesses are still identifiable at the site.

Both Garlock (LSC 410) and Boss (LSC 353) record the corner in 1972 as a found railroad spike, each providing different witnesses for the point. Here again, two witnesses from each recordation can still be identified on the ground.

By 1979, the road has been paved and in subsequent surveys a handhole has been punched through the blacktop to find the railroad spike denoting the corner. This is substantially how the corner is identified in surveys by A.F. Miller and Darrell Hughes in that year.

By 1986, however, a monument box has been placed over the railroad spike as noted in surveys by Miller '86 and '91, Desine '91, and Hughes '92 and '93. A substantial number of the witnesses from these surveys can still be recovered at the site.

Finally, the most recent survey using this corner is one furnished us by Charles E. Garlock. In January of 1994, Garlock finds a railroad spike in monument box for the SE corner of Section 27. Of the five witnesses for this point on Garlock's survey, three can still be identified on the ground.

On August 13th, 1994, this point was recovered as a railroad spike in monument box without cover. The point lies 1.5' west of the centerline of blacktop pavement running north/south, 4' north of pavement centerline to the east, and on the centerline of pavement to the west.
