

On Friday February 18th, 1825, a wood post was set by Deputy Surveyor Sylvester Sibley denoting this corner. From that time to the modern era, very few records exist concerning this point. There is nothing in the county surveyors records provided by Mr. Garlock relative to this point.

The corner first begins to appear on the public record in PA 132 Surveys performed in the early 1970's by Boss Engineering. It appears on CLS 1466 and 1466 A, although the corner material is unidentified. In 1975 a survey by Washtenaw Engineering identifies the corner as an iron pipe and employs witness ties from the previous Boss surveys. By mid-1976 the corner material was identified as an iron; again ties that originated with the Boss surveys in 1974 were utilized, and a year later, a survey by A.F.Miller introduces a fourth witness tie to complement the three from Boss'74.

In 1979, the corner was recorded by Austin C. Williams (LSC 1196) who identifies the corner material as a PK in centerline. However, only two of Williams' ties relate back to the Boss'74 surveys. Finally, a survey by Darrell Hughes in 1980 identifies the corner as a PK over a 1/2" iron. The three witnesses noted by Hughes are essentially the same three as first noted by the Boss surveys in 1974.

On October 19, 1993, fieldcrews recovered this corner as a 1/2" Iron rod 5' plus or minus south of centerline of road. One of the witness ties originating with Boss'74 was also recovered. Its location relative to corner L-11 and K-12 compares favorably with the distance noted by Miller'79, Garlock'92, and Hughes'80.
