

This standard corner was first set by Joseph Wampler in the winter of 1824. From county surveyor information provided by Mr. Garlock, this corner was monumented by an iron set by Pat Benton in 1968. These records give a distance of 70.2' East to the closing corner for the adjoining township on the south.

Benton's witnesses and identification were in use for this point until a survey by A.F. Miller in the late 70's. Miller recovers a 1" pipe with rerod. This same identification and three witnesses were utilized by Charles Garlock in recording the corner in 1979.

On October 19, 1993 fieldcrews recovered a 1/2" rerod marking this standard corner. Additionally, one witness tie dating back to Benton'68 was recovered. It's location relative to corners K-12, and L-13 compares favorably with distances noted in surveys by Miller'79 and Garlock'92. The distance to closing corner K-1 is 2.16 Feet shorter than that noted by Munsell'68 but is within 0.04' of distance noted on LSC 686 for corner K-1.
