I, MARY A. BARNWELL, in a field survey on SEPTEMBER 29, 1999 do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

I-08 Deerfield Township was set by the GLO in 1823. The original witnesses are:

Yellow Oak 16" S 71 1/2° W 4.10 ch (270.6') White Oak 18" N 71 1/2° E 1.07 ch (70.6')

NOTE: None of the original witnesses could be found or perpetuated. See the back of this sheet for additional historical data.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I-08 Found 1/2" Iron Rod at the centerline of Argentine Road (asphalt surface running North/South) - old fence line to the West

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I-08 West 1/4 Corner, Section 23, T4N, R5E - Reset 1/2" Iron Rod with 36" x 1 1/4" steel breakaway pipe with Brass Cap marked as "Livingston County Monumentation Corner" in a new Monument Box

N 22° W Set Nail/Remon Washer NE/S 30" Oak 76.11'

N 35° W Set Nail/Remon Washer NE/S 30" Oak 48.03"

N 63° W Set Nail/Remon Washer NE/S 18" Hickory 34.25

N 83° E Set Nail/Remon Washer S/S 10" Walnut 48.10"
