

A. Description of original monument and accessories and/or subsequent restoration:

(14-Sec. 20) South 1/16 between Sections 20 and 21. Not established in the original survey.

(12-Sec. 20) South 1/16 corner, Section 20. Not established in the original survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(14-Sec. 20) Established the corner midway and on the Section line between Section corner 1313.91' south and Quarter corner 1313.91' north. The position for the corner falls in the traveled surface of Hwy M-117 and was not monumented. Established a witness corner at the intersection of the South E W 1/16 line with the westerly R/W line of M-117 74.77' west of the corner position.

(12-Sec. 20) Established the corner midway and on a straight line between Quarter corner 1312.45' south and Center of Section 20 1312.45' north.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(14) Set 1"IDx36" I.pipe with 4" alum. MDNR cap (12) Set 1"IDx36" I.pipe with 4" alum.
