A. Description of original monument and accessories and/or subsequent restoration:

- L-1 North 1/4 Corner of Section 1. G. A. Shadko R.L.S. 1934 found 3/4" Iron Pipe for 1/4 Cor. in 1955. No wit. found or established.
- K-3 S.W. Section Corner of Section 1. Corner set by Wilcox, Erickson & Assoc. 6-7-73. Wit. S15°W, 27.12', 6" Maple, S55°W, 63.49', 8" Dbl. Cedar, N20°W, 66.13', 6" Pine, a 1/2" Iron and Cap was placed at corner.

B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

L-1 No pipe found. Re-established by re-tracing G. A. Shadko's 1955 survey for a "Public Fishing Site" (No. 49-5).

K-3 Could not find Wilcox, Erickson & Assoc. Iron Rod and only one of their N.B.T.'S remains Found their S<sup>1</sup>/<sub>4</sub> and S.W. Sec. Cor. of Sec. 2 and re-established this corner by re-tracing their survey for the south line of Section 2.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

1" pipe w/plastic R.L.S. Cap placed at both corners. Bearings:

- L-1 Corner set in ditch line, 6" Maple, N2°E, 45.85' & Power Pole, S85 W, 54.8' & 10" W. Birch, South, 37.65', 8" Twin Maple, S50°E, 51.8' (Tags in Trees).
- K-3 Buried in South edge of road. 8" Aspen, N5°W, 40.65' & 6" W. Birch, S1°E, 34.05' 10" Maple, \$56°W, 56.5' & Wilcox's Cedar, \$61°W, 61.4'.
