

A. Description of original monument and accessories and/or subsequent restoration:

J-1 1/4 Corner Common to Section 2, T43N, R2W & Section 35, T44N, R2W

- 1840 Original corner established by William A. Burt. Witnesses: Fir 5, N35°E 04 links Fir 6, N03°W 06 links.
- 1971 LCRC, liber A-72, Mackinac County corner records (recorded in 1973). Mary C. Feindt, P.S. 3920, placed a 3/3" iron pipe. Witnesses: Fence post, N15°E 24.8' - 6" Poplar, S25°W 40.95' - 4" Black Cherry, S60°W 44.70'. 1972 - LCRC, liber A-41, Mackinac County corner records (recorded in 1972). C. Eugene Ostling, P.S. 12026, found a
- ½" pipe. Witnesses: Fence post, N0°03"E 24.8' Fence post, S20°58'E 79.5' 4" Cherry, S49°45'W 45.0.
- 1995 LCRC, liber 9, page 247, Chippewa County corner records. Keith R. Waters, P.S. 33142, corner being perpetuated as part of the Chippewa County Remonumentation Program. Found and accepted a 1/2" i.d. (% o.d.) iron pipe. Witnesses confirm that this is the same pipe as described in both Mackinac County LCRC's. Note that this position appears to be in conflict with that as shown in a Certificate of Survey, as recorded in liber 1, pages 415-417, Mackinac County records. Replaced the pipe with a 3/4" rebar. Witnesses: Nail and tag #33142 in side of 5" Aspen, S40°W 48.26' Nail and tag #33142 in side of 3" Balsam Fir, S21°W 59.38'

Nail and tag #33142 in side of 6" Willow, S11°W 60.67"

Center of top bolt in easterly steel gate post, S16°E 75.96'

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being perpetuated as part of the Mackinac County Remonumentation Program. Found the 3/2" rebar with plastic Chippewa County Remonumentation cap and all witness objects as called for in the above mentioned Chippewa County LCRC.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Found a 3/2" rebar with plastic Chippewa County Remonumentation cap at the corner location, which falls approximately 4 feet north of the centerline of an east-west gravel road (Townline Road), at a fence line to the north and a ditch line to the south. Witnesses:

Nail and tag #33142 in side of 5" Aspen, S40°W 48.26 Nail and tag #33142 in side of 3" Balsam Fir, S21°W 59.38' Nail and tag #33142 in side of 6" Willow, S11°W 60.67'

Center of top bolt in easterly steel gate post, S16°E 75.96'
