A. Description of original monument and accessories and/or subsequent restoration:

(L3) Quarter corner common to Sections 1-12. Corner reestablished in 1980 by 8illy D. Buckler, RLS: "Placed 1/4 corner midway bet. two sec. cors. and on Morth edge of E-M road. Found several blazes on M. Maple trees in vicinity. This recording mill replace record dated 3-6-70. Placed 1° pipe with 4° aluminum cap. 16° H. Maple M71M 12.7°, 16° H.Maple S63M 32.2°, 12° H.Maple H69E 3.2°. (2-Sec. 12) East 1/16 corner between Sections 1-12. Corner established in 1979 by Billy D.Buckler, RLS: "Placed corner midway bet. Sec. Cor. to East and 1/4 cor. to Mest. Placed 1° pipe with 4° aluminum cap. 24° R. Maple H74M 29.5°, 8° H. Maple M25E 23.0°°.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner;

(L3) Recovered the 1980 monument as described, a 1° ID iron pipe capped with a 4° dia. cast aluminum MDKR tablet, in good condition, and at record bearing and distance from the 1980 witnesses, all in good condition. My measurements show this monument to be 0.06' East of the midway location intended in 1980. I accept the monument as a careful and faithful reestablishment of the position of the original corner. Made one new witness as described below. Corner recovered and rewitnessed by T.Stark and M.Feldpausch, Newberry District Office.

(2-Sec. 12) The 1979 monument was removed by unknown parties. Remonumented the corner as follows: 1) at record bearing and distance from the 1979 witnesses, both recovered in good condition; 2) midway and on a straight line between 1/4 corner to west and Section corner to east (1331.42' Mest and East) and; 3) in the remains of the hole created by the removal of the 1979 monument. At the position for the corner, I placed a 1° ID x 36° iron pipe capped with a 4° dia. cast aluminum MDNR tablet, appropriately stamped. Corner placed and witnessed by T.Stark and M.Feldpausch, Newberry District Office.
