

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(M-1) Township Corner Common to Townships T45N-R11W, T45N-R10W, T44N-R11W and T44N-R10W This corner is being perpetuated as part of the Luce County Remonumentation Program.

Recovered Buckler's corner as monumented in 1960. Could find no evidence of the original corner or any other contrary evidence. Accepted Buckler's monument for the township corner.
