- Iron as found and recorded in L. 2295 P. 438 and L. 2302 P. 900 is also recorded as I-13 T3N R13E in L. 3179 P. 740 by Wm. Soderberg and has been remonumented as I-13 T3N R13W in 1994. After reviewing MDOT Road Plans from 1938 to present and measurements along Town line from E-1 to L-1, I feel the point as recorded in L. 2302 P. 900 is actually I-13 T3N R13E. Set point at Gov. Dist. 574.2 East of I-13 for Section corner. On line between I-13/J-13 T3N R13E. (MDOT = 571.0 ± per Road Plans 1938)
