Found the 5" square Concrete Monument as described by Griffin above. Witnesses (1) and (2) have been destroyed, Witnesses (3) through (9) are standing and in good condition. I found no other evidence to dispute the location of this corner,

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: Corner Common to Sections 14, 15, 22 and 23, T.17N., R.15W.,

left the 5" square Concrete Monument in place projecting 1.0' above the ground. This corner accepted as a careful and faithful re-establishment of the position of the original corner.
