I found the iron by Ross that was set in 1982 but ignored this iron as there was no solid basis to set this iron other than the occupation from the power line, i.e. no fences or evidence of occupation, so I set the corner by single proportionate measurement between A-3 and C-3 of T17N, R16W. I found nothing to dispute the location of this corner.

The condition of the witnesses 1 and 2 are gone.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I set at the surface of the ground, by single proportionate measurement a 4" x 18 ½" Harrison cast iron monument stamped "Mason County Monument ... I accepted this as a careful and faithful reestablishment of the position of the original corner.
