I, <u>Kenneth L. Ross</u>, in a field survey on May 5, 2000, Do hereby certify that under requirements of P.A.74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

Mon. Box (no wit.) B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I found a 5/8" from rod of undetermined length inside a monument box 3.1 ft. east of the centerline of N-S and on the centerline of a road to the West.

Condition of witnesses: 1 & 2 are gone,

I found nothing to dispute the location of this corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I placed a 2 ½" aluminum cap that is stamped "Mason County Monument " on the existing 5/8" ir. It accepted this as a careful and faithful reestablishment of the position of the original corner. No additional monumentation was added.
