Description of corner evidence found and/or method applied in restoring or reestablishing corner:

found a 1 1/2" pipe with a 5/8" iron rod driven into the center inside an existing monument box. Corner is in center of N-S road and 4' south of centerline of road to the East.

Condition of witnesses: 1 and 2 are gone.

found nothing to dispute the location of this corner.

Description of monument for corner and accessories established to perpetuate locating the position of the corner:

left the 1 1/2" pipe and 1/2" iron rod in the monument box intact and accepted this as a careful and faithful reestablishment of the position of the original corner.

tie corner fence post S55E 43.95' ex. 60d spike on south side

tie S65W 37.48' Ex. 60d spike on south side.

distance North to M-11=2651.38'

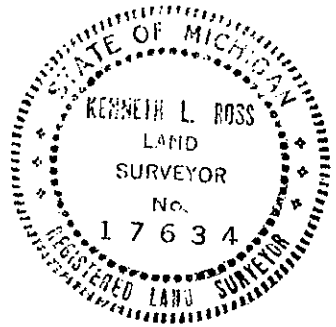
