Description of corner evidence found and/or method applied in restoring or reestablishing corner: I-1, Corner Common to Sections 2 and 3, T.18N., R.16W.,

Found '4" X 18" re-rod as riser to 1/2" X 18" re-rod as riser to 1" X 42" pipe, believed to be corner set by Towns, 3' South of Center Line of Decker Road and 3' West of Center-line of Stephens Road. I could find no other evidence to dispute the location of this corner. Witnesses (1) through (8) and (11) have been destroyed or damaged. Witnesses (9) (10) and (12) are standing and in good condition.

Description of monument for corner and accessories established to perpetuate locating the position of the corner: I-1, Corner Common to Sections 2 and 3, T.18N., R.16W.,

I replaced the 1"X 42" pipe in the exact location with a Standard 3" Cast Iron Harrison Monument stamped "Mason County Monument" 1 foot below the surface and 3 foot South of the Center-line of Decker Road. This corner accepted as the best available evidence of the re-establishment of the position of the original corner.
