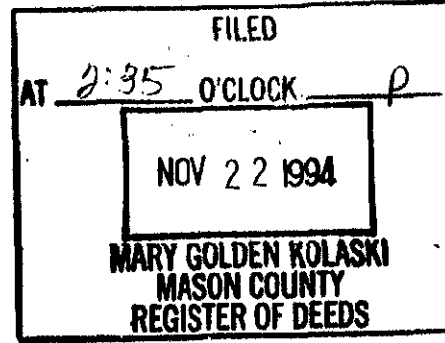

A. Description of original monument and accessories and/or subsequent restoration:

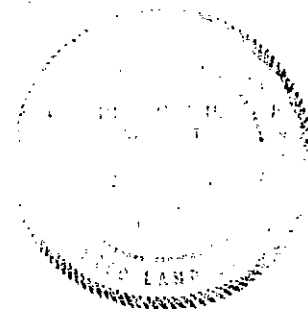
L-1 1/4 Corner, Sec. 1
 Corner not set during original government survey December, 1894, and April 7 & 8, 1895, J. A. Mitchell tied into corner without stating what was found (Book 1, Page 285 & Book 1, Page 287)

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

L-1 1/4 Corner, Sec. 1
 Found 1" Pipe ID at corner location.
 S 1/4 Sec. 36, T19N, R18W, 4.58' West.
 Matched distance as called by J. A. Mitchell within 1.83' long from the west and 8.35' long from the east.
 This corner location is accepted as a careful and faithful perpetuation of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

L-1 1/4 Corner, Sec. 1
 Set 5/8" X 24" rebar inside 1" ID pipe as found with standard 2 1/2" cap stamped "Mason County Remonumentation".
 8" Maple N 72 E 47.61'
 12" Maple S 37 E 33.70'
 18" Maple S 43 W 22.92'
 On CL Decker Road
 S 1/4 Corner Section 36, T19N, R18W, West 4.58'
