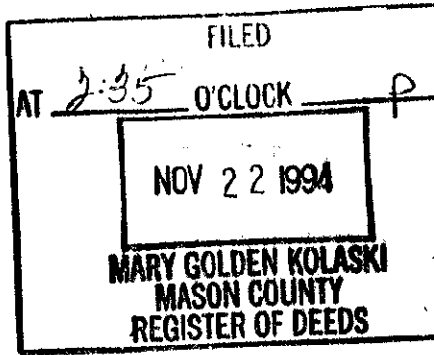

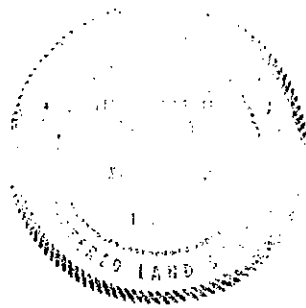

**B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:**

M-7 Section Corner, Secs. 13 & 24, 19-16; 18 & 19, 19-15  
 Found 1" X 15" iron pipe in monument box  
 Pit old witnesses and distances as described by Sam Barnett, PLS, and Ken Ross, PLS.  
 Fit distance within 7.0 feet as recorded by R. O. Towns and J. A. Mitchell.  
 This corner location is accepted as a careful and faithful perpetuation of the original corner.
