A. Description of original monument and accessories and/or subsequent restoration;

D-3, T/S, R/E, 1/4 Section Corner Common to Sections 5 & 8, ( on Albain Road 1/2 mile west of Douglas Road - Tarby )

1820, G.L.O. Surveyor, Joseph Wampler, on corrected line between Sections 5 & 8, set quarter section post and witnessed: W. Oak 14 (inch) N.6°W. 1.74 chains & W. Oak 13 (inch) N.87°E. 32 links. 1900, John VanDeventer found stone. M. Freels found stone, September 1972. Glenn Richard, January 1973, found stone, drove iron pipe beside stone bent top of same to center over stone. Used by M.R.Fleck in 73 & 74. Rerecorded by bolt, used by G.B Warnke, Jr. in 1990 and recorded in ICRC, Liber 3, Pg. 88. Used by G.B. Warnke, Jr. and others to present.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

D-3 - 8/1994, found bolt at surface. Found 3/4 inch capped iron pipe (No. unknown), 10 inches deep. Found stone (granite) 20 inches deep, 6 inch X 6 inch top X 18 inch X 18 inch bottom, 20 inches long. Unable to move stone. Set 6 inch PVC pipe under monument box over high point of stone and witnessed as shown below. 12/21/1994, drilled hole in stone and set 1/2 inch x 13 inch rebar with brass remonumentation cap, with bottom of rebar in drill hole.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

D-3 - Set 1/2 inch x 13 inch rebar with brass remonumentation cap in monument box, with rebar set in drill hole in found stone, and is accepted as the best available evidence of the position of the original

corner and Witnesses:

North 55° East 50.68 feet to found nail/shiner in southwest face of electric pole

South 5° West 23.66 feet to found #60 nail in east face of 18 inch Maple

South 456 feet to found PK nail in north face of 36 inch Oak

South 50° 35.21 feet to found PK nail in north face of 20 inch Oak South +/- 3 feet to centerline pavement Albain Rd.
