B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

E-8 - 9/15/1994, dug 24 inch x 30 inch deep hole and found 5/8 inch iron rod and found 10 inch x 12 inch stone at 15 inches deep and 0.7 feet south and 0.5 feet west of found iron rod. Removed stone, excavated and probed, no further evidence found. Older witnesses fit within 0.04 feet. Reset iron rod in bottom of hole and placed 1 inch x 36 inch iron pipe over rod and witnessed as shown below. 9/29/94, set brass remonumentation cap on 1 inch x 36 inch iron pipe.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
