

B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

Corner is located in Suder Avenue - 1/2 mile south of Yarge ville Road in gravel pavement. 9/99 - Found 1/2" x 30" rod bent but twisted to NW - checked some witnesses but couldn't make work - rod was on east side - twisted to west & used point of stone. Set 1" x 36" pipe with set brass remonumentation cap in post hole 8" diameter - 36" deep filled with gravel to 24" depth. Found smaller stone at 36" depth but considered it incidental – broke through stone to drive the pipe. No post found. Position of LCRC witnesses were not very specific. Comer did not appear used recently – very compact stone & soil. Placed some clear glass around pipe at 24" deep +/-. Laid RR spike on south edge & ½" x 8" rebar on north edge 20" deep & set stone on south edge.

RATIFIED BY PEER GROUP, PA 345 OF 1990, MONROE COUNTY, MICHIGAN, DATE 10/12/1999, COUNTY REP. Corner is accepted as the best available evidence of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Set 1" x 36" pipe with brass remonumentation cap & Witnesses:

West 33.06 feet to found 3/8" iron rod

East 32.96 feet to found 3/8" iron rod

North 25° East 66.42 feet to set nail & remonumentation disc in west face of 15" Cottonwood - 2' above ground

East 41.39 feet to set nail & remonumentation disc in south face of 16" Walnut

South 10° East 136.75 feet to set nail & remonumentation disc in west face of 16" Walnut - used AJM measurement
