B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

Corner is located at Yargerville road (E-W) & Dunlap Road (S) in asphalt pavement.

9/3/1999 – found "+" cut railroad spike. Found ¼" rod 0.3' deep 0.03 foot north & 0.12 foot west. Split difference. Dug hole 32" deep. Set 5/8" x 12" rebar & some clear glass and railroad spike & ½" x 24" rod at bottom of hole. The ½" rod appeared to be quite old but straight. Set 1" x 36" iron pipe with set brass remonumentation cap in set monument box. The original witnesses fit fairly well but were quite low so we set new nails & shiners.

RATIFIED BY PEER GROUP, PA 345 OF 1990, MONROE COUNTY, MICHIGAN, DATE 10/12/1999, COUNTY REP. This position was not established by original government surveyors. This monument is accepted as the best available evidence of the position of the corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Set 1" x 36" pipe with set brass remonumentation cap in set monument box to replace found railroad spike & rod & Witnesses:
