- A. Description of original monument and accessories and/or subsequent restoration:
 - A-7, T8S, R7E, Bedford Township, Monroe County ID No. 58

Section Corner Common to Sections 18 & 19, T8S, R7E on west township line & Sections 13 and 24, T8S, R6E) (Temperance Road being west of Summerfield Road - hard surface) (Common to M-7, 1785, R6E) 1820, G.L.O. Surveyor, Joseph Wampler, set corner post, no bearing trees, 3 feet deep water in marsh area for M-7, T8S, R6E. 1820, G.L.O. Surveyor, Joseph Wampler, Intersect W. Boundary at post for A-7, T8S, R7E. 1902, Harry Gard, County Survey Book 3, found old stone, no witness trees. 1960, A.J. Marino survey refers to a Case and Fleck survey, but notes no stone found. Does not mention what is at corner. 1966. Case and Fleck survey does not state monumentation. 1981, G.B. Warnke used found R.R. spike over conc. culvert (Survey No. 81-28). 1987, James C. Andrus used found existing railroad spike at Northwest corner, Northwest quarter, Section 19 (Survey No. 875-4906).

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

A-7 - 11/16/1994, found magnetic reading under witnesses for railroad spike crossing concrete culvert

approximately 1 foot under crossing. Did not excavate. Awaiting further instructions. 12/15/1994, set 1/2 inch x 13 inch rebar with brass remonumentation cap in monument box to replace railroad spike; rebar stabilized in drilled hole in center of 54 inch diameter cross culvert for Indian Creek (culvert 1.5 feet

under ground).

Λ-7 - Set 1/2 inch x 13 inch rebar with brass remonumentation cap inside monument box, to replace railroad spike, and is accepted as the best available evidence of the position of the original corner and Witnesses:

South 10° East 23.87 feet to cross cut in 54 inch concrete culvert

North 10° West 24.55 feet to cross cut in 54 inch concrete culvert

South 50° East 66.34 feet to PK nail in south face of electric pole
