A. Description of original monument and accessories and/or subsequent restoration:

II-3, T8S, R7E, 1/4 Corner Between Sections 3 & 10 (On Samaria Road [M-151] - West of Ann Arbor Railroad)

1820, G.L.O. Surveyor, Joseph Wampler, set quarter post at average distance. Witnesses: W. Oak 40 (inch) East 29 links & W. Oak 24 (inch) N.24°W. 72 links. / Old book notes a stone. / A.J. Marino survey, dated May 10, 1946, notes a plug. / Witness card by L.J. Czubak, Survey Chief, dated March of 1964, notes found railroad spike. / Witness card by W.D. Fletcher, Survey Chief, dated 10-11-65, notes boat spike in monument box. / Monument box, iron in monument box, or iron pin in monument box has been used in the 70's to present. / G.B. Warnke set hex head bolt over pin in monument box without cover.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

IF-3 - On 9/17/1993, Found hex bolt at surface of monument box without lid and witnessed. On 10/27/1993. checked old witness from stone northwest to steps on house. Spoke with owner of residence and found that steps were replaced about 20 years ago and are essentially the same type of steps - witnesses: old 48.5 feet & new 52.86 feet to boat spike. 12/21/1994, set plastic remonumentation cap on bolt.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

II-3 - Found hex bolt at surface with set plastic renonumentation cap in monument box without lid and is accepted as the best available evidence of the position of the original corner and witnesses:

North 3° East 24.18 feet to nail in south face of telephone pole

North 16° East 63.25 feet to southwest corner of house No. 1362

South 41° East 36.33 feet to nail in northwest face of electric pole

South 20° West 50.18 feet to northeast corner of brick porch of house No. 1405
