Description of corner evidence found and/or method applied in restoring or re-establishing corner: Corner is located at intersection of Substation road & Suder avenue - 3" tarby over 3" gravel over 18" heavy stone. 5/26/99 - Dug 2' diameter x 30" hole. Railroad bolt at surface. Used 3' offset east & north. Found small 0.2 x 0.2 railroad rail on end 8" deep the center is 0.1 to east. Found pieces of pottery, clay pots, green glass & pieces of brick at 15 - 24" deep around vertical rail. Found 1" x 2" x 12" stake drove in top of 1" diameter pipe against west edge of rail with top of pipe about 20" deep. Probed to 42" deep with no further evidence found. Could wood hub have been found by A.J. Marino crews in 1948 & 1954? — probably! Placed pottery, etc. around

base of rail. Note the railroad crossing bolt would have been over wood stake in 1" pipe. Set monument box at surface if pavement. 9/21/99 - set brass remonumentation cap on 1/2" rebar in 1" pipe at west edge of flange of rail in set monument box
