B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

Corner is located in Erie Road / in asphalt over concrete pavement / 1/2 mile east of Grodi & 1/2 mile east of I-75. 5/1999 - Found small PK / witnessed set nail & shiner 4.00 east & north. Found 2 witnesses from 1968 MSHD to an auto engine valve which fell 0.35 east & 0.4 south of PK nail. Dug through 4" asphalt – 6" to 8" of concrete pavement was deteriorated or broken up. Auto valve not found. Dug hole SW to NE 28" x 20" x 24" deep. Used post hole digger 8" diameter x 14" - found some wood - 1 piece appears charred. Set 3/4" pin in bottom inside 3-1/2" clay tile using 2 witnesses to valve. Set 1" x 36" pipe over pin in monument box. 9/21/99 – set brass cap on 1" x 36" iron pipe.

West 156 feet to centerline of concrete drive south Consumer's Power
