CORNER SHOWN ON PLAT OF GREEN VALLY RESORT, RECORDED IN LIBER 9 OF PLATS PAGE 56, MONTCALM COUNTY RECORDS. FOUND NO DIHER RECORD EVIDENCE.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(17) ORIGINAL CORNER POST AND ACCESSORIES NOT RECOVERED. CAUKIN'S MONUMENTS WERE NOT SEARCHED FOR. FOUND 1" IRON BAR IN BITUMINOUS PAVEMENT OF N-S ROAD. MY MEASUREMENTS NORTH AND EAST TO ADJACENT CORNERS ARE 2619.06" AND 2709.86" RESPECTIVELY. THESE ARE IN VERY SINILAR PROPORTION TO CAUKIN'S 1887 MEASUREMENTS. THIS CORNER WAS LOCATED DURING A TRAVERSE OF SECTION 14 FOR A SURVEY OF THE MICHIGAN DEPARTMENT OF NATURAL RESOURCES PUBLIC ACCESS SITE ON THE SOUTH SHORE OF 5th LAKE. THE CORNER WAS NOT NECESSARY TO THE SURVEY AND IS BEING RECORDED FOR INFORMATION DNLY. I NEITHER ACCEPT NOR REJECT THIS MONUMENT AS PERPETUATING THE ORIGINAL POSITION OF 17. (J6) ESTABLISHED CORNER AT THE INTERSECTION OF STRAIGHT LINES CONNECTING OPPOSITE 1/4 CORNERS, ALL AS RECORDED THIS DATE. FOUND NO MONUMENTATION AT THIS POSITION. THE LOCATION FOR J6 AS COMPUTED FROM FOUND DRIGINAL MONUMENTATION OF THE PLAT OF GREEN VALLEY RESORT AND THE RECORD DIMENSIONS SHOWN ON THE FACE OF THE PLAT, IS ABOUT 12' NORTH OF THE EAST-WEST 1/4 LINE AND APPROXIMATELY IN LINE WITH AN OLD FENCELINE EXTENDING NORTH AND SOUTH. NO MONUMENTATION WAS FOUND AT THIS POSITION AND IT WAS REJECTED AS ERRONEOUS. AT THE POSITION FOR THE CORNER, I PLACED A 1/2"x36" REBAR ENCASED IN A 4" DIAMETER CONCRETE CYLINDER CAPPED WITH A CAST ALUMINUM MICHIGAN DEPARTMENT OF NATURAL RESOURCES TABLET AND SET WITHIN A STANDARD CAST IRON MONUMENT BOX SET FLUSH WITH THE BITUMINOUS SURFACE OF FLECK ROAD. THE CORNER MONUMENTED FALLS IN LINE WITH THE OLD FENCE NORTH AND SOUTH.
