

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found a 2 3/4" x 32" cast-iron monument with "County Surveyor Legend." Verified witnesses with LCRC, Liber 1242, Page 306. Old fence post at corner, no wire visible above ground. The position of the existing corner was accepted due to historical usage and documentation. No double corner or closing corner by G.L.O.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

A 2 3/4" x 32" cast-iron monument with a "County Surveyor Legend" was found. N 30° E 25,731 Found spike E side of 12" Maple N 83° E 39.40' Set spike N side of 8" Oak S 55° E 21.77 Set spike NE side of Twin 4" x 8" Oak S 35° E 18.50' Found spike SW side of 12" Oak S 25° W 22,72 Found spike SE side of 28" Maple Found spike S side of 32" Oak N 75° W 17.13
