A. Description of original monument and accessories and/or subsequent restoration:

- 2 - East 1/16 Cor. on the North Sec. line of Sec. 28; not previously established.
- 3 - N. 1/16 Cor. on the West Sec. line of Sec. 28; not previously established.
- 6 - NE 1/16 on Sec. 28; not previously established.

B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

- 2 - Set M.P.O.L. between the North 1/4 Cor. and the N.E. Sec. Cor. of Sec. 28. A 3/4" iron rod (not of record) bears N39°W 49.55' from Cor. Mon.
- 3 - Set M.P.O.L. between the W. 1/4 Cor. and the N.W. Sec. Cor. of Sec. 28. A 3/4" iron rod, not of record, bears S51°W 12.5' from Cor. Mon.
- 6 - Set at the computed Ctr. of the N.E. 1/4 of Sec. 28 by closed traverse.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

- 2 - 1" pipe, 4" aluminum cap; 7" Spruce - N85°W - 13.0'; 7" Bl. Cherry - N8°W - 27.7'; 6" Bl. Cherry - N71°E - 38.3'; 5" Spruce - S11°E - 17.75'; 3/4" iron rod - M39°W - 49.55'.
- 3 - 1" pipe, 4" aluminum cap; 4" Bl. Spruce - S71°E - 19.7'; 6" Bl. Spruce - N22°E - 21.2'; 5" Bl. Spruce - S4°W - 10.7'; 5" Tam. - N81°W - 13.8'; 3/4" iron rod - S51°W - 12.5'.
- 6 - 1" pipe, 4" aluminum cap; 20" W. Pine - N87°W - 18.5'; 6" B. Spruce - S42°W - 22.2'; 12" B. Spruce - S16°E - 50.0'; 7" R. Maple - S76°E - 11.8'.
