Corner purportedly was restored at that position on 10-13-66 by B. D. Buckler, who placed a 3" x 3" x 4-1/2' squared & scribed cedar post for a monument. Subsequent remeasurement of this sec. line by the undersigned disclosed that Buckler's post was N15°W 5.0 ft. from the true midpoint location as intended. I moved the corner to the position he intended to occupy and installed a new monument described below. Corner 3: Established 11-1-79 on line between Sec. Cor. 20.013 ch. N and 1/4 cor. 20.013 ch. S.
